

Mt Henry Loyalty Card

Terms & Conditions

1. Introduction

1.1 These Terms and Conditions set out the rights and obligations of membership to the Mt Henry Tavern Loyalty Card.

1.2 Whilst every effort has been made to ensure the information provided to Members in relation to the Mt Henry Tavern Loyalty Club is correct, the Mt Henry Tavern accepts no responsibility for any inaccuracy or miss descriptions.

2. Definitions

2.1 In these Terms and Conditions unless the context otherwise requires:

“Award” means any item obtained by the Member through Mt Henry Tavern Loyalty Club.

“Mt Henry Tavern Loyalty Club” means the Award & Benefits program conducted by the Mt Henry Tavern for Mt Henry Tavern customers who become Members.

“Benefits” means any of the specials, discounts or promotions offered or available to the Member from time to time as a result of membership in “Mt Henry Tavern Loyalty Club”.

“Card” means the Mt Henry Tavern Loyalty Club card issued to the member.

“Frequent Buyer Scheme” means the program conducted by the Mt Henry Tavern whereby Members earn Points for purchases made and may redeem these Points for Awards.

“Member” means a person whose name is printed on the Card.

“Points” means points earned by the Member for purchases made at the Mt Henry Tavern in accordance with the point earning rates as calculated by the Mt Henry Tavern from time to time.

“Terms and Conditions” mean these Terms and Conditions, as amended from time to time.

3. Changes to the Terms and Conditions

3.1 Terms and Conditions will not be changed except in writing by the Mt Henry Tavern.

3.2 The Mt Henry Tavern will use reasonable endeavors to advise Members of any changes, but is not liable in any way for failure to do so. The Mt Henry Tavern may use contact details provided to contact customers of any changes made to Terms and Conditions.

3.3 The Mt Henry Tavern reserves the right to make any changes to the Terms and Conditions at its sole discretion, including but not limited to changes to:

- Earning of points
- Points earning rates
- Expiry of accrued points
- Redeeming Points

3.4 The Mt Henry Tavern reserves the right in its absolute discretion to withdraw, cancel or in any way change any of the Awards or Benefits previously advertised or offered to the Member, at any time, and the Mt Henry Tavern will not be liable for any loss or damage suffered by the Member resulting from such withdrawal, cancellation or change.

4. Termination

4.1 The Mt Henry Tavern reserves the right at any time its absolute discretion and without notice to revoke membership of the Member and/or the right of the Member to use the Card or to utilize any Award Benefit.

4.2 Any breach of these Terms and Conditions by the Member whether intentional or otherwise may result in termination of membership.

4.3 A breach of these Terms & Conditions includes, but is not limited to, the Member in the reasonable opinion of the Mt Henry Tavern:

- Supplying or attempting to supply misleading information or making any misrepresentation to the Mt Henry Tavern
- Acting in any way which is likely to be detrimental to the interests of the Mt Henry Tavern or the Mt Henry Tavern Loyalty Club.

4.4 In the event of termination accumulated Points will be cancelled.

5. Membership

5.1 Membership of the Mt Henry Tavern Loyalty Club is open only to individuals of at least 18 years of age. Membership is open to companies or partnerships at the discretion of the Mt Henry Tavern.

5.2 Membership is offered at the discretion of the Mt Henry Tavern, and has the right to accept or reject any application for membership.

5.3 The Member is responsible for advising the Mt Henry Tavern of any change of name, address or any other contact details.

5.4 Membership will terminate automatically on the death of the member. Points earned but not redeemed at the time of death will be cancelled.

6. Use of the Card

6.1 By the use of the card the Member agrees to be bound by the Terms and Conditions.

6.2 The Card is and remains property of the Mt Henry Tavern and must be returned on demand.

6.3 The card is valid for use only by the member and it is not transferable in any circumstances.

6.4 The Mt Henry Tavern will credit Points to the Member's card when the Member makes a purchase at the Mt Henry Tavern.

6.5 Points may only be credited to one Card.

6.6 Accumulated Points cannot be sold, assigned, transferred or otherwise redeemed whether for valuable consideration or otherwise.

6.7 The Mt Henry Tavern may automatically tally the accumulated Points of the Member every 12 months from the end of the month the member because a Member.

6.8 Points may be redeemed for Awards when the Member has Points equal, to or greater than, the Points required to redeem such awards.

6.9 When claiming an Award, Points will automatically be redeemed in the order they were earned.

6.10 Points may be redeemed for Awards when the Member has points equal to or greater than the Points required to redeem such Awards.

6.11 The Mt Henry Tavern will clearly display the Points required to redeem each award.

6.12 The Member must produce the Card to receive any Awards or Benefits.
